Short description of the financing or investment operation:

The purpose of the proposed investment operation is to renew and extend an educational campus of the FAA located in Meudon (in the southwestern suburbs of Paris) to meet regulatory standards and ensure adequate learning and living environments are provided to the vulnerable and disadvantaged young people enrolled in education and training. The site includes a lower secondary school, an upper secondary professional school, several training programmes, a boarding school, a children's refuge, a day centre and an emergency reception centre. Today it is caring for, training, educating and integrating some 600 young people in distress, including 60 unaccompanied minors (third-country nationals).

The investment operation will be implemented in five phases:

The main objective of the FAA is to reach secondary school students and families at risk and provide them with educational and social opportunities to support their socio-economic integration. Once completed, the project will result in a modern campus location, combining an innovative pedagogical approach and high-quality facilities.

Through this investment, the FAA aims to provide the educational campus with an improved layout and learning and living environment for all campus users (including young people, teachers and educators, administrative staff on the campus, service providers and the outside public). It aims to do so by constructing new facilities and adapting existing buildings to increase capacity and better respond to the education demands of today, ensuring safety and accessibility. The investment will also contribute to improve the energy efficiency of existing buildings.

The education services provided by FAA will contribute to increase the employability and income-earning potential of graduates, by supporting the completion of their studies and preventing school dropout. The comprehensiveness of the education and social services provide through the FAA also facilitate access to boarding room if needed, a training to secure employment and facilitate access to social services.
